The deadline for submission is on August 30, 2022, by midnight. We will, however, stop accepting submissions after 100 requests are received.

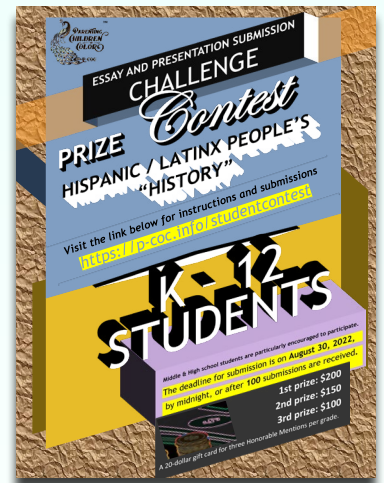

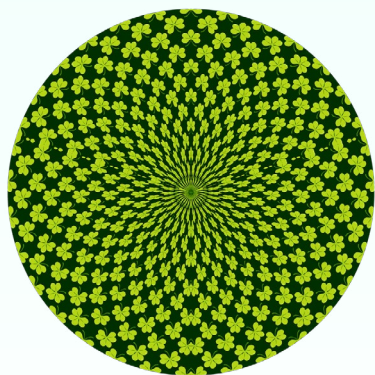

## P-COC'S STATEMENT ON THE RECENT SURGE OF GUN VIOLENCE IN OUR COMMUNITIES

A sad reality is slowly and severely affecting how our communities aim to evolve day by day. Recent developments involving gun violence remind us that there is much work to be done to bring drastic changes to the accessibility of firearms. The P-CoC family exhorts our elected officials and law enforcement agencies to continue working together to strengthen current laws while closing the gap on existing loopholes. In an ever-changing society, it is imperative to express our concern and demand swift action to bring adjustments to present policies. Nonetheless, bipartisan efforts must be implemented to assess how these constitutional regulations reflect the current crisis we are experiencing. 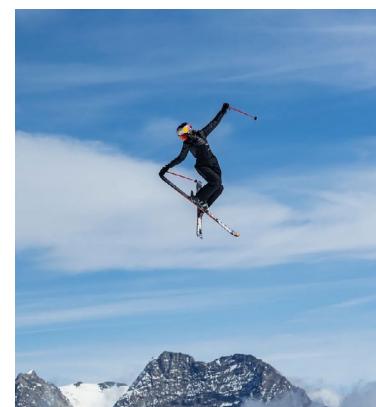

## GEOPOLITICS AND ASIAN ATHLETES IN AMERICA

Some Americans wanted Eileen Gu, the gold-medal winning skier from California to fit an old-style Asian American identity. Instead she represented China at the Olympics, and her 'transnational fluidity' vexed many.

They judged Ms. Gu critically, sometimes harshly. Nativist biases about Asians in this country were triggered. Despite belief in this country about the primacy of individual choice and opportunity, and that athletes often play for other countries, opinions of Eileen Gu's choice carried familiar and loaded sentiments such as 'taking advantage of America', 'patriotism', and 'citizenship'.

People of color negotiate multiple domains of acceptance. Many also navigate attachment to heritage and adopted cultures. Both sets of experiences expand the boundaries of being American. Transnational athletes are another example of how these times challenge our biases.
